- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to modify a reenlistment and advancement under the provisions of the Selective Training and Reenlistment (STAR) program.
- 2. The Board, consisting of Mr. Pfeiffer, Mr. Zsalman, and Mr. George, reviewed Petitioner's allegations of error and injustice on 31 January 2011 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. The 5 year reenlistment executed on or about 17 September 2010 is null and void.
- b. The Petitioner was discharged on 28 February 2009 and reenlisted, under the provisions of the STAR program, on 1 March 2009. The term is 5 years.
- c. This change will entitle the member to a zone "A" SRB with an award level of 4.0 for the MMSS/4231 rate/NEC. Remaining obligated service to 26 February 2011 will be deducted from SRB computation.
- d. The Petitioner's previous zone "A" SRB payment should be adjusted to reflect recent zone "A" entitlement.
- e. The Petitioner was advanced to Petty Officer Second Class effective "1 March 2009" vice "17 September 2010".
- f. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
- 4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
