REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed written application, enclosure (1), with this Board requesting, in effect, that his naval record be corrected by removing, from the Marine Corps Total Force System (MCTFS), his assignment to weight control from 7 January to 3 June 2000, a copy of which is at Tab A. He also impliedly requested removing the service record page 11 ("Administrative Remarks (1070)") entry dated 15 February 2000, a copy of which is at Tab B.

2. The Board, consisting of Messrs. Bourgeois, J. Hicks and Ivins, reviewed Petitioner's allegations of error and injustice on 10 February 2011, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to the Board, Petitioner exhausted all administrative remedies which were available under existing law and regulations within the Department of the Navy.

b. In correspondence at enclosure (2), the Headquarters Marine Corps office with cognizance over the subject matter of

this case has commented to the effect that the request has merit and warrants favorable action.

c. The page 11 on which the contested entry appears also includes uncontested entries.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of enclosure (2), the Board finds an error warranting the following corrective action:

RECOMMENDATION:

a. That Petitioner's naval record be corrected by removing, from MCTFS, the assignment to weight control from 7 January to 3 June 2000.


b. That his record be corrected further by removing the service record page 11 ("Administrative Remarks (1070)") entry dated 15 February 2000. This is to be accomplished by reconstructing the page 11 on which the entry appears, or by completely obliterating the entry so it cannot be read, rather than merely lining through it.

c. That any material or entries inconsistent with or relating to the Board's recommendation be corrected, removed or completely expunged from Petitioner's record and that no such entries or material be added to the record in the future.


d. That any material directed to be removed from Petitioner's naval record be returned to the Board, together with a copy of this Report of Proceedings, for retention in a confidential file maintained for such purpose, with no cross reference being made a part of Petitioner's naval record.

4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
