- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to authorize an entitlement to Basic Allowance for Housing (BAH).
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 15 August 2016 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds that prior to applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.


CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. Petitioner had a dependent child, on 30 May 2014. Petitioner was divorced from his active duty spouse on 19 November 2014. Note: Child was born out of wedlock and is not the dependent of the ex-spouse.
- b. Petitioner was authorized with dependent rate BAH vice single rate BAH, for his dependent child, for the Military Housing Area (MHA) from 30 May 2014 to 4 November 2014 (date of transfer).



c. Petitioner was authorized with dependent rate BAH vice single rate BAH, for his dependent child, for the from 5 November 2014 to 20 July 2015 (date of transfer).
d. Petitioner was authorized with dependent rate BAH vice single rate BAH, for his dependent child, for the from 21 July 2015 to 19 April 2016. Note: Effective 20 April 2016, Petitioner is receiving with dependent rate BAH for his dependent child,
e. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter. Recorder
