1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to authorize an entitlement to Basic Allowance for Housing (BAH).

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 10 April 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds that prior to applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Petitioner is authorized with dependent rate BAH for her dependent's location of [REDACTED] from 25 April 2014 through 13 May 2016. Note: Petitioner had an acquired dependent while executing orders to [REDACTED] Petitioner did not receive a housing allowance for her dependent spouse for the duration of her unaccompanied overseas tour.

b. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
