- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Petitioner reenlisted and was advanced under the provisions of the Selective Training and Reenlistment (STAR) program.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 30 January 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. The Petitioner executed an immediate reenlistment contract (NAVPERS 1070/601) on 17 June 2016 for a term of "6 years" vice "3 years". Additionally, the following paragraph is added "Career designated in accordance with MILPERSMAN 1160-100."
 - b. The Petitioner was advanced to Petty Officer Second Class effective 17 June 2016.
- c. This change will entitle the member to a zone "A" SRB with an award level of 9.5 (\$100,000 dollar award ceiling) for the ELTNUC (SW)/3386 rate/NEC. Remaining obligated service to 2 April 2018 will be deducted from SRB computation.
 - d. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
- 4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
