- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that the Petitioner has established a Special Needs Trust (SNT) in order to establish direct payment of a dependent child Survivor Benefit Plan (SBP) annuity directly to the SNT.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 8 September 2016 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows: before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. Prior to his 30 April 2000 transfer to the retired list the Petitioner submitted a timely and properly filled out request to enroll in SBP for spouse and child coverage, at the full base amount, which included his incapacitated dependent son,

 Note: Petitioner established a Special Needs Trust (SNT) for his son.
 - b. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
