

- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show that he participated in a Navy Wide Advancement Exam.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 21 November 2016 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds that prior to applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

CONCLUSION

Upon review and consideration of all the evidence of record, and due to deployment, the cycle 231 NWAE was received by the Petitioner out of cycle; therefore, upon receipt of the answer sheet by NETPDTC, the exam was not graded. The Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. The Petitioner's answer sheet from the March 2016 cycle 231 NWAE is graded and valid.
- b. Note: the Naval Education and Training Professional Development Center (NETPDTC)

will grade the cycle 231 answer sheet and, if a high enough Final Multiplier Score (FMS) is achieved, will advance the Petitioner. If the minimum required FMS is not achieved, NETPDTC will correct the record to reflect that the exam was taken and any passed not advanced (PNA) points that may have been earned will be applied to future E6 exams.

- c. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
- 4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
