1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show timely written request to elect "child only" coverage under the Survivor Benefit Plan (SBP).

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 23 March 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 9 May 2016, Petitioner and his spouse signed a DD Form 2656 electing "child only" SBP coverage.

c. On 31 October 2016, Petitioner transferred to the Fleet Reserve and was automatically enrolled in maximum spouse SBP coverage.

#### CONCLUSION

Upon review and consideration of all the evidence of record, especially in light of the fact that an administrative error may have caused the automatic enrollment in SBP coverage by Defense Finance and Accounting Services, the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. Prior to his 31 October 2016 transfer to the Fleet Reserve, Petitioner elected "child only" SBP coverage with spouse concurrence. Any other election or declination executed by Petitioner is null and void.

b. A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
