1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to September 2016 Cycle 232 Navy Wide Advancement Examination (NWAE) be graded against the March 2016 Cycle 231 NWAE.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 23 May 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board agrees that the Petitioner did not have the opportunity to participate in the March 2016 Cycle 231 NWAE due to no fault of his own. The Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The Final Multiple Score (FMS) on the Examination Profile Information and Exam Status sheet for Cycle 231 was "94.51". Note: after comparing September 2016 cycle 232 NWAEE against March 2016 cycle 231 NWAEE, Petitioner's FMS exceeded the minimum FMS of 20.00 required to be advanced to OS3.

The Petitioner was advanced to Petty Officer Third Class effective 16 December 2016 vice 16 June 2017.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
