1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting that the applicable naval record be corrected to establish entitlement to retroactive Special Duty Assignment Pay (SDAP).

2. The Board, consisting of ██████████ reviewed Petitioner's allegations of error and injustice on 30 August 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application found that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board found that Petitioner's SDAP was not processed in a timely manner. In light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was entitled to SDAP retroactive from 5 December 2015 through 1 September 2016 while assigned as Master Explosive Ordnance Disposal Technician (Navy Enlisted Classification Code 5337), at Explosive Ordnance Disposal Training and [REDACTED] (Unit Identification Code: [REDACTED]). Petitioner authorized SDAP at the SD-6 level (\$450 per month) vice SD-5 level (\$375 per month). Note: Request that Defense Finance and Accounting Service credit Petitioner with the SDAP difference which was paid previously.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
