1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to be advanced to E5.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 5 September 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board agrees that the Petitioner's request for an advancement determination was approved by the command on 26 January 2017, within the time allowed, but was not forwarded up to Navy Personnel Command until 21 April 2017; after the time allowed, due to no fault of the member. The Board finds the existence of an injustice warranting the following corrective action.

The Petitioner's approved request for an advancement determination was forwarded to Navy Personnel Command (PERS-812) on 26 January 2017 and it was approved.

The Petitioner was advanced to OS2/E-5 from the March 2016 Cycle 231 Navy Wide Advancement Examination (NWAE) effective 16 September 2016 with a time in rate (TIR) date of 1 July 2016.
