- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show transfer of points for two separate years from one anniversary year to another and transfer to the retired reserve awaiting pay at age 60.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 22 August 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The Petitioner's discharge of 1 November 2014 is rescinded.

Transfer 1 point from the anniversary year ending 8 July 1996 to the anniversary year ending 16 July 1997. This action will establish a satisfactory year for 16 July 1997 anniversary year.

Transfer 18 points from the anniversary year ending 16 July 2005 to the anniversary year ending 16 July 2006. This action will establish a satisfactory year for 16 July 2006 anniversary year.

The Petitioner submitted for transfer to the Retired Reserve awaiting pay at age 60 and it was approved by competent authority with an effective retirement date of 31 October 2014. Petitioner completed 20 years of qualifying service.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
