- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to establish entitlement to a zone "B" Selective Reenlistment Contract (SRB).
- 2. The Board, consisting of Petitioner's allegations of error and injustice on 27 October 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting corrective action due to the following: on 2 March 2017, Petitioner received orders with an obligation of service to November 2020. Petitioner's End of Active Obligated Service was 4 June 2020. Furthermore, Petitioner was eligible to reenlist and receive a SRB; however, due to improper counseling, Petitioner failed to obligate prior to detaching and thus lost his eligibility to reenlist and receive a SRB.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

The 6 month agreement to extend enlistment (NAVPERS 1070/621), operative on or about 5 June 2020 is null and void.

The Petitioner was discharged on 30 March 2017 and reenlisted on 31 March 2017. The term is 6 years.

This change will entitle the Petitioner to a zone "B" SRB with an award level of 1.0 (30,000 dollar amount ceiling) for the AG/7412 Rate/NEC. Remaining obligated service to 4 June 2020 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
