- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to receive entitlement to a zone "B" Selective Reenlistment Bonus.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 23 June 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

- a. Paragraph 8b (Remarks) of the DD Form 4/1 executed on or about 13 January 2015 for a term of 4 years and 5 months, is modified to read "I understand that this reenlistment contract is contingent upon my successful completion of the training requirements for MOS 0372. Should I fail to complete the training requirements for MOS 0372, I may be administratively separated from the Marine Corps." vice "I understand that this reenlistment contract is contigent upon my successful completion of the training requirements for MOS 0321. Should I fail to complete the training requirements for MOS 0321, I may administratively separated from the Marine Corps."
- b. Note: Petitioner executed a 23 month agreement to extend enlistment (NAVMC 321A), on or about 19 April 2017.
- c. This change will entitle the Petitioner to a zone "B" SRB for MOS 0372, which is capped at \$46,750 for 48 months of additional obligated service. Remaining obligated service to 30 May 2015 will be deducted from SRB computation.
 - d. A copy of this Report of Proceedings will be filed in Petitioner's naval record.
- 4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
