1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show the Petitioner declined enrollment in the Survivor Benefit Plan (SBP).

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 24 August 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. On 2 June 2016, Petitioner's spouse signed a DD Form 2656 declining SBP spouse coverage. On 9 June 2016, Petitioner signed the DD Form 2656 declining SBP spouse coverage. Due to this administrative error, the Defense Finance and Accounting Service (DFAS) automatically enrolled Petitioner in maximum SBP spouse coverage. DFAS requires the spouse to sign the DD Form 2656 after the Petitioner in cases where spouse coverage is declined or elected at a reduced rate.

c. Petitioner turned 60 years old and began receiving retirement pay on 5 November 2016.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the Petitioner and spouse's intent to decline SBP coverage, the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Prior to turning age 60 and receiving retirement pay on 5 November 2016, Petitioner declined enrollment in SBP with spouse concurrence. Any other election or declination executed by Petitioner is null and void.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
