1. Pursuant to the provisions of reference (a), Petitioner, a commissioned officer in the Marine Corps, filed enclosure (1) with this Board requesting that the fitness reports covering the period from 4 July 2008 to 20 September 2008 be removed from his Official Military Personnel File (OMPF). He also impliedly requested that his failure of selection (FOS) by the FY18 Major Selection Board be removed from his OMPF. Enclosures (1) through (3) apply.

2. The Board, consisting of ██████████ reviewed Petitioner's allegations of error and injustice on 18 October 2017, and pursuant to its regulations, determined that the partial corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations and policies. In addition, the Board considered the action taken by Headquarters Marine Corps (MMRP-13/PERB) Memorandum dated 14 June 2017 and MMRP-50 Memorandum dated 20 June 2017.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Petitioner was issued a To Temporary Duty (TD) fitness report for the reporting period 4 July 2008 to 20 September 2008.

c. On 14 June 2017, Headquarters Marine Corps took corrective action by modifying the contested report. See enclosure (2).

d. Headquarters Marine Corps recommends the removal of Petitioner's FOS by the FY18 Major Selection Boards. See enclosure (3).

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of enclosure (3), the Board finds the existence of an injustice warranting the following partial corrective action:

RECOMMENDATION:

Petitioner's naval record be corrected by removing his FOS incurred by the FY18 Major Promotion Selection Board.

Petitioner's naval record be corrected so that he will be considered by the earliest possible selection board convened to consider officers of his category for promotion to major as an officer who has not failed selection for promotion to that grade.

That no further relief be granted.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
