- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show the Petitioner declined enrollment in the Survivor Benefit Plan (SBP).
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 25 January 2018 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
 - b. On 29 November 2016, Petitioner transferred to the Permanent Disability Retired List.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting corrective action due to the following: On 29 November 2016, Petitioner was transferred to the Permanent Disability Retired List. Petitioner claims that he was not provided counselling regarding the obligation to submit a DD Form 2656 prior to retirement to decline enrollment in SBP coverage. Because Petitioner did not submit a DD Form 2656 declining SBP coverage prior to medical retirement, the Defense Finance and Accounting Service (DFAS) automatically enrolled the Petitioner in maximum SBP spouse coverage. The Board concurred with the Petitioner's claim that he received insufficient counseling regarding his obligations under the SBP and, as such, the Board concluded that a measure of relief is warranted in this case.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

Prior to his 29 November 2016 transfer to the Permanent Disability Retired List, Petitioner declined enrollment in SBP with spouse concurrence. Any other election or declination executed by Petitioner is null and void.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
