1. Pursuant to the provisions of reference (a), Petitioner, a former enlisted sailor, filed enclosure (1) with this Board requesting that his Certificate of Release or Discharge from Active Duty (DD Form 214) be corrected to reflect the correct Social Security Number (SSN).

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 12 December 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of naval records, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. The SSN on Petitioner's DD214 is incorrect. The SSN currently reads [REDACTED] but the correct SSN should be [REDACTED] Petitioner provided a copy of his Social Security card.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants favorable action.

The Board notes Petitioner's SSN is incorrect on his DD Form 214.

In view of the foregoing, the Board finds the existence of an error warranting the following corrective action.

RECOMMENDATION:

Petitioner naval record be corrected to show that his SSN is [REDACTED]

Petitioner shall be issued a DD Form 215 reflecting the correct SSN.

Upon request, the Department of Veterans Affairs be informed that Petitioner's application was received by the Board on 12 July 2017.
