1. Pursuant to the provisions of the reference, Petitioner, a former enlisted member of the Navy, filed enclosure (1) with this Board requesting that his record accurately reflect medals and awards that he earned during his periods of military service.

2. The Board, consisting of [REDACTED] reviewed Petitioner's allegations of error and injustice on 6 November 2017 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion (AO) provided by the Navy Department Board of Decorations and Medals (NDBDM). See enclosures (1) through (4).

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to waive the statute of limitations and review the application on its merits.

c. Petitioner enlisted in the Navy and began a period of active duty on 13 February 1990. He was discharged with an honorable characterization of service on 22 February 1996. His active duty service included his deployment to the Arabian Gulf, Mediterranean Sea and North Atlantic. His DD Form 214 issued on 22 February 1996 reflects that he earned the National Defense Service Medal and the Meritorious Unit Commendation.

d. The AO in enclosure (4) provided by NDBDM advised that Petitioner is entitled to the Southwest Asia Service Medal with one Bronze Campaign Star.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concluded that Petitioner's request warrants relief. In this regard, the Board substantially concurred with the AO and concluded that during his period of service, Petitioner earned the Southwest Asia Service Medal with one Bronze Campaign Star.

In view of the above, the Board directs the following corrective action.

RECOMMENDATION:

Petitioner be issued a DD Form 215 to correct Block 13 of his DD Form 214 issued on 22 February 1996, by adding the Southwest Asia Service Medal with one Bronze Campaign Star.

That a copy of this report of proceedings be filed in Subject's naval record.

That, upon request, the Department of Veterans Affairs be informed that Petitioner's application was received by the Board on 23 August 2017.
