- 1. Pursuant to the provisions of reference (a) Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show the Petitioner declined enrollment in the Survivor Benefit Plan (SBP).
- 2. The Board, consisting of allegations of error and injustice on 8 February 2018 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. On 16 August 2005, Petitioner divorced
- c. On 31 May 2017, Petitioner transferred to the Fleet Reserve and was automatically enrolled in "spouse" SBP coverage. Petitioner was not married at the time.

## CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting corrective action due to the following: Petitioner was previously married; however, not married at the time of her transfer to the Fleet Reserve on 31 May 2017. Defense Finance and Accounting Service (DFAS) automatically enrolled her in "spouse" SBP coverage. The Board concluded that Petitioner did not want to participate. As such, the Board determined that a measure of relief is warranted in this case.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Prior to her 31 May 2017 transfer to the Fleet Reserve, Petitioner declined enrollment in SBP. Petitioner was unmarried at the time. Any other election or declination executed by Petitioner is null and void.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
