The Board notes it is in the interest of justice to correct block 28 to reflect Petitioner's choice of "most significant duty assignment" on his DD Form 214.

In view of the foregoing, the Board finds the existence of an error warranting the following corrective action.


RECOMMENDATION:

Petitioner shall be issued a Correction to Form DD Form 214 (DD Form 215) reflecting his most significant duty assignment as Medical Battalion, Marine Division" when he was discharged on 19 May 1953.

A copy of this report of proceedings be filed in Petitioner's naval record.

Upon request, the Department of Veterans Affairs be informed that Petitioner's application was received by the Board on 24 August 2017.
