- 1. Pursuant to the provisions of reference (a), Petitioner, an enlisted member of the Marine Corps, filed enclosure (1) with this Board requesting the removal of his Administrative Remarks (Page 11) counseling entry dated 19 February 2015, from his Official Military Personnel File (OMPF).
- 2. The Board, consisting of allegations of error and injustice on 22 November 2017, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the Petitioner's application, together with all material submitted in support thereof, relevant portions of the Petitioner's naval record and applicable statutes, regulations and policies. Enclosures (1) through (4) apply.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. On 19 February 2015, the Petitioner signed a Page 11 counseling which stated in part, that he failed to obey a lawful order given by an Airborne Instructor. When corrected by the Airborne Instructor he gave a disrespectful response. See Enclosure (2).
- c. Petitioner contends that the Page 11/6105 was not signed by the Commanding Officer, it was signed by the Operations Officer.

d. Petitioner submitted enclosure (3) and (4) as evidence on his behalf to demonstrate who the Commanding Officer was at the time of the issuance of the Page 11 and the Commanding Officer's signature.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concluded that Petitioner's request warrants favorable action.

In reaching its conclusion, the Board after careful consideration of the Petitioner's record, determined that the Petitioner submitted sufficient evidence to support his request to have removed enclosure (2) from his OMPF. The Board concluded that the Page 11 is an injustice and therefore, the removal of the Page 11 from the Petitioner's naval record should be granted.

In view of the foregoing, the Board recommends the following corrective action:

RECOMMENDATION:

Petitioner's naval record be corrected by removing enclosure (2) from the Petitioner's OMPF.
