This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

A three-member panel of the Board, sitting in executive session, considered your application on 30 April 2024. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations, and policies. In addition, the Board considered the advisory opinion contained in Commander, Navy Personnel Command memorandum 1000 PERS-313 of 16 October 2023 and Commander, Navy Pay and Personnel Support Center memorandum 1000 N1 of 29 December 2023 and your responses to the opinions.

You requested to correct your career history, assignment history, school history and duty station data from Navy Standard Integrated Personnel System, Fleet Training Management and Planning System, My Navy Assignment, and Bureau of Naval Personnel (BUPERS) Online to show your full prior service history. In addition, you requested to correct your time in service (TIS), time in grade, and dates of rank. Lastly, you stated the Navy has no history of your awards and decorations. The Board, in its review of your entire record and application, carefully weighed all potentially mitigating factors, to include your assertions. The Board concluded that BUPERS Instruction 1070.27E provides guidance for determining which documents should be submitted to Naval Personnel Command (PERS-313) for filing into the official military personnel file (OMPF). PERS-313 has updated your OMPF to reflect three of your prior service DD Form 214, Certificate of Release or Discharge from Active Duty and training course completion certificates. However, the Board determined that you will need to contact the MyNavy Career Center (MNCC) regarding updating your corporate data. Additionally, the Board determined your Pay Entry Base Date, Active Duty Service Date, and TIS are correct. No error could be found and you provided no explanation or evidence that your TIS is incorrect. After more than a four year break in service, you were authorized by the enlisted community manager to enlist as an Seaman/E-3 upon initial enlistment and Hospital Corpsman (HM3)/E-4 after completion of the Hospital Corpsman (HM) Class "A" School. On 4 October 2021, you entered the Navy as an E-3, completed HM Class "A" School on 7 April 2022 and advanced to HM3/E-4 the same day. In this connection, the Board substantially concurred with the comments contained in the advisory opinions and determined that no further changes to your record is warranted.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
