1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect declined participation in the Survivor Benefit Plan (SBP).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 14 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 3 April 2013, Petitioner entered active duty.

b. On 26 June 2014, Petitioner married [REDACTED] and they had one child: [REDACTED]
[REDACTED] e born on [REDACTED].

c. Petitioner transferred to the Temporary Disability Retired List (TDRL) effective 29 July 2023 and automatically enrolled in SBP Spouse only coverage because the Defense Finance and Accounting Service (DFAS) did not receive Petitioner's DD Form 2656, Data for Payment of Retired Personnel.

d. On 12 August 2024, Petitioner and his spouse both signed an affidavit before a notary witness indicating that they desired Petitioner's SBP election to be changed to reflect that he

declined SBP coverage. Petitioner indicated that he “received insufficient SBP information/counseling prior to [his] date of retirement.”

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an error warranting the following corrective action. The Board concluded Petitioner provided sufficient evidence to reflect his and spouse’s desire to decline SBP coverage. Although Petitioner did not complete the proper administrative requirements, the Board determined that under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner’s naval record be corrected, where appropriate, to show that:

Petitioner elected to decline participation in SBP coverage with proper spouse concurrence prior to transferring to the TDRL effective 29 July 2023.

Note: The DFAS will complete an audit of Petitioner’s pay records to determine amounts due, if any.

That a copy of this report of proceedings be filed in Petitioner’s naval record.

4. It is certified that a quorum was present at the Board’s review and deliberations, and that the foregoing is a true and complete record of the Board’s proceedings in the above titled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
