error a remedi	Board, having reviewed all the facts of record pertaining to Petitioner's allegations of and injustice, found that, before applying to this Board, he exhausted all administrative es available under existing law and regulations within the Department of the Navy. The made the following findings:
	On 30 June 2001, Petitioner married and then divorced on 20 January Notice of Entry of Judgement did not direct SBP Former Spouse coverage.
	On 21 April 2006, Petitioner signed DD Form 2656, Data for Payment of Retired nel and elected to decline coverage because he did not have any dependents.
c. I	Petitioner transferred to the Retired List effective 1 June 2006.
d. ( child:	On 24 March 2012, Petitioner married and they had one born on 1 August 2013.
e. (	On 26 June 2014, Petitioner signed and submitted DD Form 2656-6, Survivor Benefit Plan

to change SBP coverage from no coverage to Spouse and Child coverage based on acquiring a new dependent child.

- f. The DFAS changed Petitioner's election to SBP Child coverage effective 1 August 2014.
- g. On 22 August 2014, the DFAS notified Petitioner "We regret to inform you that you are unable to add your spouse to your Survivor Benefit Plan (SBP). You would have had to notify us prior to your first year anniversary in order for your spouse to have been eligible. Child coverage has been established on your account."
  - h. On 14 September 2020, Petitioner's child, was born.
- i. On 17 October 2020, Petitioner signed and submitted DD Form 2656-8, Survivor Benefit Plan (SBP) Automatic Coverage Fact Sheet, listing your spouse and both children. The DFAS updated Petitioner's SBP coverage to reflect the youngest child's date of birth.
- j. On 18 May 2023, Petitioner signed Letter of Intent to Enroll During the SBP Open Season to enroll in SBP Spouse and Children coverage. However, Petitioner was ineligible because he was already enrolled in SBP prior to 22 December 2022.
- k. On 27 December 2023, Petitioner requested the DFAS reconsider repeated denial of SBP Spouse coverage enrollment.

## **CONCLUSION**

Upon review and consideration of all the evidence of record, the Board finds the existence of an error warranting the following corrective action. The Board concluded Petitioner provided sufficient evidence to reflect his desire to add SBP Spouse coverage for his current spouse, however failed to notify Defense Finance and Accounting Service of marriage to within 1-year of their nuptials. Although Petitioner did not complete the proper administrative requirements in a timely manner, the Board determined that relief is warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected SBP Spouse coverage naming as beneficiary at the full retired pay level of coverage within 1-year of marriage on 24 March 2012. Note: SBP Child coverage was properly established within 1-year of first child's birth on 1 August 2013 and youngest child's date of birth has been added to Petitioner's account.

Note: No waiver of unpaid premiums will be granted.

That a copy of this report of proceedings will be filed in Petitioner's naval record.
