1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show establish Petitioner's enlistment contract (DD Form 4) dated 4 January 2023 Item 8 as Naval Reserve vice Navy.

2. The Board, consisting of **Example**, **Example**, and **Example** reviewed Petitioner's allegations of error and injustice on 22 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 4 January 2023, Petitioner entered the U.S. Naval Reserve for 8 years with an Expiration of Obligated Service of 3 January 2031.

b. On 4 January 2023, Petitioner signed an Enlistment Guarantees (NAVCRUIT 1133/52) Annex "A" to DD Form 4 dated 4 January 2023 listing the following acknowledgement: ACKNOWLEDGEMENT In connection with my enlistment into the United States Navy (Reserve) Component, I hereby acknowledge that I am enlisting for a total Military Service Obligation (MSO) of 8 years. I fully understand and acknowledge that my MSO consists of on active-duty obligation of 4 years as indicated In the options listed below with the remaining months 48 of my MSO served in either the Selected Reserve (SELRES) or Individual Ready Reserve (IRR). In any case, I may be ordered to the SELRES for the remainder of my MSO bated on the needs of the Navy (AC only). I understand my contract has the following

guaranteed options which require the indicated active-duty service obligation(s). Furthermore, Option 1: Personnel Specialist (PS/SG) Class "A" School Guarantee. This required a 4-year active-duty obligation.

c. On 7 February 2023, Petitioner entered active duty for 4 years with an End of Active Obligated Service of 6 February 2027.

d. On 17 March 2023, Petitioner was issued official change duty orders (BUPERS order: ) while stationed in the stationer is intermediate (01) activity was the effective date of departure of April 2023. Petitioner's intermediate (01) activity was the effective date of arrival of 20 April 2023. Petitioner's intermediate (02) activity was the effective date of arrival of 22 May 2023. Petitioner's ultimate activity was the effective date of arrival of 22 May 2023. Petitioner's ultimate activity was the effective date of arrival of 4 July 2023 with a projected rotation date of July 2027.

e. On 3 April 2023, Petitioner signed an Enlistment Guarantees (NAVCRUIT 1133/52) Annex "B" to DD Form 4 dated 4 January 2023 listing the following acknowledgement: ACKNOWLEDGEMENT: In connection with my enlistment into the United States Navy (Reserve) Component, I acknowledge that I am enlisting for a total MSO of 8 years. I fully understand and acknowledge that my MSO consists of an active-duty obligation of 4 years as indicated in the options listed below with the remaining months 48 of my MSO served in the IRR. I understand my contract has the following guaranteed options which require the indicated active-duty service obligation(s). Furthermore, Option1: Full Time Support (FTS) / Personnel Specialist (PS) Class "A" School. This required a 4-year active-duty obligation.

f. Petitioner's Navy Standard Integrated Personnel System/Electronic Service Record, Member Data Summary, pulled on 19 August 2024, listed the following: Branch Class USNR and Special Program Indicator: FTS Enlisted.

g. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that Petitioner enlisted for the PS Rate in the FTS which is a Navy Reserve program, however due to administrative error, her enlistment contract listed Navy vice Naval Reserve.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's enlistment/reenlistment document (DD Form 4) executed on 4 January 2023 listed item B8 (Agreements) NAVAL RESERVE vice NAVY.

That a copy of this report of proceedings be filed in Petitioner's naval record.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
