- c. On 24 July 2023, Petitioner entered active duty.
- d. On 4 October 2023, Petitioner's Master Military Pay Accounting record reflects \$10,000 enlistment bonus was processed for payment.
- e. On 5 October 2023, Petitioner completed Recruit Basic Military training.
- f. On 16 November 2023, Petitioner issued BUPERS Order: 3203 (Official Separation Orders) with Separation Program Designator (SPD) of "JFC;" Character of Service Entry Separation Lump Sum Leave Authorized; and an effective date of 24 November 2023.
- g. On 24 November 2023, Petitioner discharged and issued DD Form 214, Certificate of Release or Discharge from Active Duty reflecting 4-months and 1-days of active duty service; Uncharacterized Character of Service; "JFC" Separation Code; "RE-3E" Reentry Code; and Erroneous Entry for Narrative Reason for Separation.
- h. On 23 January 2024, Defense Finance and Accounting Service issued Petitioner an indebtedness letter in the amount of \$9,159.72 for recoupment of unearned portion of enlistment bonus due to SPD code "JFC."
- i. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded Petitioner met the criteria to keep the entire EBSHP in accordance with reference (b). Therefore, the Board determined that under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's EBSHP indebtedness is rescinded in accordance with reference (b).

Note: The Defense Finance and Accounting Service will complete an audit of Petitioner's pay records to determine amounts due, if any.

A copy of this report of proceedings will be filed in Petitioner's naval record.
