1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 13 May 2021 for 3 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 30 April 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 6 May 2014, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 5 May 2018 and Soft EAOS (SEAOS) of 5 May 2020; "Training in the nuclear field program and advancement to E-4, per BUPERSINST 1036.78 and MILPERSMAN 1160-040, 1160-080, and 1510-030. I understand that this extension becomes binding upon execution and may not be cancelled except as set forth in MILPERSMAN 1160-040. In particular, I understand that, when I accept advancement to E-4, 12 months of this agreement may not be cancelled, whether or not I complete nuclear power or advanced training."

- b. In October 2016, Petitioner was awarded Navy Enlisted Classification (NEC) N24O.
- c. On 28 November 2016, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 28 December 2016 for duty.
- d. On 6 July 2017, Petitioner reenlisted for 6 years with an EAOS of 5 July 2023 and received a Zone A SRB.
- e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- f. In accordance with reference (c), FY20 SRB Award Plan (N13SRB 003/FY20), a Zone “B” SRB with an award level of 6.5 (\$100,000 award ceiling) for the EMN(SW)/N24O/S rate/NEC was listed.
- g. On 6 May 2020, Petitioner entered Zone B.
- h. On 2 July 2020, Petitioner was issued official change duty orders (BUPERS order: 1840), with required obligated service to May 2024 while stationed in [REDACTED] with an effective date of departure of December 2020. Petitioner’s intermediate (01) activity was [REDACTED] for temporary duty under instruction with an effective date of arrival of 11 January 2021. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 1 May 2021 with a Projected Rotation Date of May 2024. Obligated service to May 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- i. On 1 September 2020, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 10-month agreement to extend enlistment with an SEAOS of 5 May 2024.
- j. On 29 December 2020, Petitioner transferred from [REDACTED], and reported to [REDACTED] on 25 January 2021 for temporary duty.
- k. In accordance with reference (d), FY21 SRB Award Plan (N13SRB 003/FY21), a Zone “B” SRB with an award level of 7.5 (\$100,000 award ceiling) for the EMN(SW)/N24O/S rate/NEC was listed.
- l. On 12 May 2021, Petitioner transferred from [REDACTED], and reported to [REDACTED] on 12 May 2021 for duty.

m. In November 2021, Petitioner was awarded NEC N24S. In July 2022, Petitioner was awarded NEC 805A.

n. On 8 February 2024, Petitioner was issued official separation orders (BUPERS order: 0394) while stationed in [REDACTED] with an effective date of departure of May 2024. Petitioner's place elected for travel: [REDACTED] with an actual date of separation of 5 May 2024.

o. On 26 April 2024, NSIPS/ESR shows a 1-month agreement to extend enlistment with an SEAOS of 5 June 2024.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 6 May 2020, Petitioner entered Zone B. On 2 July 2020, Petitioner was issued BUPERS order: 1840 with required obligated service to May 2024. At that time, a Zone B SRB was authorized in accordance with reference (c). On 1 September 2020, NSIPS/ESR shows a 10-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 13 May 2021, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 10-month agreement to extend enlistment (NAVPERS 1070/621) operative on 6 July 2023 is null and void.

Petitioner's 1-month agreement to extend enlistment (NAVPERS 1070/621) operative on 6 May 2024 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 1 September 2020 agreeing to extend enlistment for 10 months for OBLISERV to May 2024.

Petitioner was discharged 12 May 2021 and reenlisted on 13 May 2021 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.5" (\$100,000 award ceiling) for the EMN(SW)/N24O rating/NEC. Remaining obligated service to 5 July 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED]

at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
