1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 14 May 2022 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constant and Active and Constant and Constant and Petitioner's** allegations of error and injustice on 9 July 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 12 May 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 11 May 2019 and Soft EAOS (SEAOS) of 11 May 2021; "[t]raining in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 7 March 2017, Petitioner transferred from on 7 March 2017 for duty. , and arrived to

c. On 14 June 2017, Petitioner reenlisted for 6 years with an EAOS of 13 June 2023 and received a Zone A SRB.

d. In September 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N15S.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 001/FY21), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S, rate/NEC was listed.

g. On 2 November 2020, Petitioner was issued official change duty orders (BUPERS order: 3070) with required obligated service to March 2024, while stationed in **Service**, **Serv**

h. On 29 January 2021, Petitioner signed an agreement to extend enlistment for 10 months with an SEAOS of 13 April 2024 in order to incur sufficient obligated service to execute BUPERS order 3070.

i. On 19 February 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

j. On 19 February 2021, Petitioner transferred from **19**, and arrived to on 23 March 2021 for duty.

k. On 12 May 2021, Petitioner entered Zone B.

l. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 002/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S, rate/NEC was listed.

m. On 8 February 2024, Petitioner signed an agreement to extend enlistment for 5 months with an SEAOS of 13 September 2024 while awaiting BCNR adjudication.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 2 November 2020, Petitioner was issued BUPERS order: 3070 with required obligated service to March 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 29 January 2021, Petitioner signed an agreement to extend enlistment for 10 months to meet the OBLISERV. On 12 May 2021, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 14 May 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 10-month agreement to extend enlistment (NAVPERS 1070/621) executed on 29 January 2021 is null and void.

Petitioner's 5-month agreement to extend enlistment (NAVPERS 1070/621) executed on 8 February 2024 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 29 January 2021 agreeing to extend enlistment for 10 months for OBLISERV to March 2024.

Petitioner was discharged 13 May 2022 and reenlisted on 14 May 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N15S, rating/NEC. Remaining obligated service to 13 June 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will<u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). LT**MEN** at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive.
