- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 25 June 2022 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).
- 2. The Board, consisting of present and injustice on 25 June 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 22 June 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 21 June 2019 and Soft EAOS (SEAOS) of 21 June 2021; "Training in the Nuclear Field. MILPERSMAN 1530-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to rate and grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete nuclear power or advanced training."

b. On 29 June 2017, Petitioner transferred from on 18 July 2017 for duty.
c. On 23 February 2018, Petitioner reenlisted for 6 years with an EAOS of 22 February 2024 and received a Zone A SRB.
d. In August 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N73Z.
e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
f. In October 2020, Petitioner was awarded NEC N13S.
g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 002/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.
h. On 16 February 2021, Petitioner was issued official change duty orders (BUPERS order:) with required obligated service to August 2024, while stationed in with an effective date of departure of July 2021. Petitioner's ultimate activity was for duty with an effective date of arrival of 13 August 2021 with a Projected Rotation Date (PRD) of August 2024. Obligated service to August 2024, is required for this assignment which may be satisfied by reenlistment of extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
i. On 17 April 2021, Petitioner got married.
j. On 7 May 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 6-month agreement to extend enlistment with an SEAOS of 22 August 2024.
k. On 22 June 2021, Petitioner entered Zone B.
1. On 13 July 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.
m. On 13 July 2021, Petitioner transferred from on 11 August 2021 for duty.

- n. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 002/FY22), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.
 - o. In March 2023, Petitioner was awarded NEC N33Z.
 - p. On 15 February 2024, Petitioner's both dependent children were born.

q. On 16 April 2024, Petitioner was issued official change duty orders (BUPERS order:
with required obligated service to March 2028, while stationed in
, with an effective date of departure of August 2024.
Petitioner's ultimate activity was growing, and the property of the property o
effective date of arrival of 6 September 2024 with a PRD of March 2028. Obligated service to
March 2028, is required for this assignment which may be satisfied by reenlistment or extension
of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB,
refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRE
eligible sailors.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 16 February 2021, Petitioner was issued BUPERS order: with required obligated service to August 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 7 May 2021, NSIPS/ESR shows a 6-month agreement to extend enlistment to meet the OBLISERV. On 22 June 2021, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 25 June 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 6-month agreement to extend enlistment (NAVPERS 1070/621) operative on 23 February 2024 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 7 May 2021 agreeing to extend enlistment for 6 months for OBLISERV to August 2024.

Petitioner was discharged 24 June 2022 and reenlisted on 25 June 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13S, rating/NEC. Remaining obligated service to 22 February 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.
