- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 24 June 2021 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 2 April 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 22 June 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 21 June 2019 and Soft EAOS (SEAOS) of 21 June 2021; "Training in the Nuclear Field, MILPERSMAN 1510 030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 19 December 2015, Petitioner got married.
c. In July 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N25O.
d. On 5 July 2017, Petitioner transferred from and arrived to
on 24 July 2017 for duty.
e. On 24 February 2018, Petitioner reenlisted for 6 years with an EAOS of 23 February 2024 and received a Zone A SRB.
f. On 20 December 2018, Petitioner's first child was born.
g. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
h. On 12 January 2021, Petitioner's second child was born.
i. On 3 February 2021, Petitioner was issued official change duty orders (BUPERS order: 0341), while stationed in with an effective date of departure of July 2021. Petitioner's ultimate activity was for duty with an effective date of arrival of 30 September 2021 with a Projected Rotation Date of October 2024.
j. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 003/FY21), a Zone "B" SRB with an award level of 7.5 (\$100,000 award ceiling) for the MMN(SW)/N25O/S rate/NEC was listed.
k. On 14 June 2021, Petitioner was issued official modification to change duty orders (BUPERS order: 0341) with required obligated service to July 2024, while stationed in with an effective data of departure of July 2021. Petitioner's
with an effective date of departure of July 2021. Petitioner's intermediate (01) activity was for temporary duty under instruction with an effective date of arrival of 24 July 2021. Petitioner's ultimate activity was for duty with an effective date of arrival of 1 October 2021 with a Projected Rotation Date of July 2024. Obligated service to July 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

1. On 22 June 2021, Petitioner entered Zone B.



m. On 28 June 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 5-month agreement to extend enlistment with an SEAOS of 23 July 2024.

- n. On 12 July 2021, Petitioner transferred from and arrived to on 25 July 2021 for temporary duty.
 - o. In August 2021, Petitioner was awarded NEC 803R.
 - p. On 27 August 2021, Petitioner transferred from on 1 October 2021 for duty.
- q. On 1 April 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 14 June 2021, Petitioner was issued official modification to BUPERS order: 0341 with required obligated service to July 2024. At that time a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 22 June 2021, Petitioner entered Zone B. On 28 June 2021, NSIPS/ESR shows a 5-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have been advised to reenlist upon entering Zone B vice extend enlistment. On 24 June 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents, if he so chooses.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 5-month agreement to extend enlistment (NAVPERS 1070/621) operative on 24 February 2024 is null and void.

Petitioner was discharged 23 June 2021 and reenlisted on 24 June 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.5" (\$100,000 award ceiling) for the MMN(SW)/N25O, rating/NEC. Remaining obligated service to 23 February 2024 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 24 June 2021 reenlistment, upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.
