1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 20 July 2022 for 3 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Construction**, **Construction**, and **Construction** reviewed Petitioner's allegations of error and injustice on 28 May 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 7 January 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 6 January 2019 and Soft EAOS (SEAOS) of 6 January 2021; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510 -030. months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 16 March 2017, Petitioner transferred from S	, and arrived to
on 16 April 2017 for duty.	

c. On 9 May 2017, Petitioner transferred from **Constant and arrived to Constant**, and arrived to **Constant**, and arrived to **Cons** 

d. On 18 July 2017 Petitioner reenlisted for 6 years with an EAOS of 17 July 2023 and received a Zone A SRB.

e. In January 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N26S.

f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

g. In August 2020, Petitioner was awarded NEC N33Z.

h. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 001/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the MMN(SW)/N26O/S, rate/NEC was listed.

i. On 25 November 2020, Petitioner was issued official change duty orders (BUPERS order: ) with required obligated service to July 2024, while stationed in the service of the service of

j. On 1 December 2020, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 12-month agreement to extend enlistment with an SEAOS of 17 July 2024.

k. On 7 January 2021, Petitioner entered Zone B.

1. On 1 February 2021, Petitioner transferred from **Example 1**, and arrived to **Example 2** on 4 February 2021 for temporary duty under instruction.

n. On 27 December 2021, Petitioner was awarded NEC N76Z.

o. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 003/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SW)/N26O/S, rate/NEC was listed.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 25 November 2020, Petitioner was issued BUPERS order: with required obligated service to July 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 1 December 2020, NSIPS/ESR shows a 12-month agreement to extend enlistment to meet the OBLISERV. On 7 January 2021, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 20 July 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

### RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 12-month agreement to extend enlistment (NAVPERS 1070/621) operative on 18 July 2023 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 1 December 2020 agreeing to extend enlistment for 12 months for OBLISERV to July 2024.

Petitioner was discharged 19 July 2022 and reenlisted on 20 July 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SW)/N26S, rating/NEC. Remaining obligated service to 17 July 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). **Control** at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive.
