1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 22 January 2021 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constitution**, and **Constitution**, and **Constitution**, and **Constitution**, and **Constitution**, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 21 January 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 20 January 2019 and Soft EAOS (SEAOS) of 20 January 2021; "Training in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 23 June 2017, Petitioner transferred from	, and arrived to

c. On 5 December 2017, Petitioner reenlisted for 6 years with an EAOS of 4 December 2023 and received a Zone A SRB.

d. On 22 February 2020 Petitioner got married.

e. In August 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N25S.

f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 002/FY21), a Zone "B" SRB with an award level of 7.5 (\$100,000 award ceiling) for the MMN(SW)/N25O/S rate/NEC was listed.

h. On 5 January 2021, Petitioner was issued official change duty orders (BUPERS order:) with required obligated service to June 2024, while stationed in the service of the station of the static of the station of the station of the static of the

i. On 21 January 2021, Petitioner entered Zone B.

j. On 1 April 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 6-month agreement to extend enlistment with an SEAOS of 4 June 2024.

k. On 1 May 2021, Petitioner transferred from **Constant and arrived to Constant and Constan**

1. On 10 May 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 5 January 2021, Petitioner was issued BUPERS order: with required obligated service to June 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 21 January 2021, Petitioner entered Zone B. On 1 April 2021, NSIPS/ESR shows a 6-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) vice extend enlistment. On 22 January 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents, if he so chooses.

Subj: REVIEW OF NAVAL RECORD ICO XXX-XX-

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 6-month agreement to extend enlistment (NAVPERS 1070/621) operative on 5 December 2023 is null and void.

Petitioner was discharged 21 January 2021 and reenlisted on 22 January 2021 for a term of 4 years.


Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.5" (\$100,000 award ceiling) for the MMN(SW)/N25S, rating/NEC. Remaining obligated service to 4 December 2023 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 22 January 2021 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). **The second seco**
