1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 1 March 2021 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 30 April 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 26 February 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 25 February 2019 and Soft EAOS (SEAOS) of 25 February 2021; "Training in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be canceled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be canceled whether or not I complete Nuclear Power or Advanced Training."

b. On 10 March 2017, Petitioner reenlisted for 6 years with an EAOS of 9 March 2023 and received a Zone A SRB.

c. On 10 April 2017, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 10 April 2017 for duty.

d. In March 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N54Z and 766A.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 001/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N140/S rate/NEC was listed.

g. On 23 December 2020, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]), with required obligated service to May 2024 while stationed in [REDACTED] with an effective date of departure of April 2021. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 20 May 2021 with a Projected Rotation Date of May 2024. Obligated service to May 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

h. In accordance with reference (d), FY21 SRB Award Plan (N13SRB 003/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N140/S rate/NEC was listed.

i. On 26 February 2021, Petitioner entered Zone B.

j. In March 2021, Petitioner was awarded NEC N14S.

k. On 9 March 2021, Petitioner signed an agreement to extend enlistment for 14 months with an SEAOS of 9 May 2024 in order to incur sufficient obligated service to execute BUPERS order [REDACTED].

l. On 20 April 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

m. On 20 April 2021, Petitioner transferred from [REDACTED] and reported to [REDACTED] on 20 May 2021 for duty.

n. On 13 November 2021, Petitioner got married.

o. On 9 April 2024, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record shows a 6-month agreement to extend enlistment with an SEAOS of 9 November 2024.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 23 December 2020, Petitioner was issued BUPERS order: [REDACTED] with required obligated service to May 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 26 February 2021, Petitioner entered Zone B. On 9 March 2021, Petitioner signed an agreement to extend enlistment for 14 months to meet the OBLISERV. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) vice extend enlistment. On 1 March 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 14-month agreement to extend enlistment (NAVPERS 1070/621) executed on 9 March 2021 is null and void.

Petitioner's 6-month agreement to extend enlistment (NAVPERS 1070/621) operative on 10 May 2024 is null and void.

Petitioner was discharged 28 February 2021 and reenlisted on 1 March 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.0" (\$100,000 award ceiling) for the EMN(SS)/N14S rating/NEC. Remaining obligated service to 9 March 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
