- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 29 April 2021 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 4 June 2024, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 28 April 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 27 April 2019 and Soft EAOS (SEAOS) of 27 April 2021; "Training in the Nuclear Field Program, and advancement to E-4, per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be canceled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that, when I accept advancement to E-4, 12 months of this agreement may not be canceled, whether or not I complete Nuclear Power or Advanced Training."

b. In June 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N13O.
c. On 27 July 2017, Petitioner transferred from and arrived to on 27 July 2017 for duty.
d. On 29 December 2017, Petitioner reenlisted for 6 years with an EAOS of 28 December 2023 and received a Zone A SRB.
e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In June 2020, Petitioner was awarded NEC N73Z.

- g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 002/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.
- h. On 3 February 2021, Petitioner was issued official change duty orders (BUPERS order: 0341) with required obligated service to July 2024, while stationed in with an effective date of departure of June 2021. Petitioner's ultimate activity was for duty with an effective date of arrival of 16 July 2021 with a Projected Rotation Date of July 2024. Obligated service to July 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
 - i. On 16 February 2021, Petitioner got married.
- j. In accordance with reference (d), FY21 SRB Award Plan (N13SRB 003/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.
 - k. On 28 April 2021, Petitioner entered Zone B.
- 1. On 24 May 2021, Petitioner signed an agreement to extend enlistment for 7 months with a SEAOS of 28 July 2024 in order to incur sufficient obligated service to execute BUPERS order 0341.
- m. On 16 June 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

n. On 16 June 2021, Petitioner transferred from	and ar	rived to

o. On 24 May 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

on 17 July 2021 for duty.

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 3 February 2021, Petitioner was issued BUPERS order: 0341 with required obligated service to July 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 28 April 2021, Petitioner entered Zone B. On 24 May 2021, Petitioner signed a 7-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) vice extend enlistment. On 29 April 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents if he so chooses.


RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 7-month agreement to extend enlistment (NAVPERS 1070/621) executed on 24 May 2021 is null and void.

Petitioner was discharged 28 April 2021 and reenlisted on 29 April 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13O, rating/NEC. Remaining obligated service to 28 December 2023 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 29 April 2021 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.



A copy of this Report of Proceedings will be filed in Petitioner's naval record.
