1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to reflect satisfactory years for anniversary years ending 8 April 2008, 8 April 2009, 8 April 2010, and 8 April 2017.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 22 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 9 April 2002, Petitioner enlisted in the Naval Reserve to completed Officer Candidate School from 18 April 2002 to 18 July 2002.

b. On 19 July 2002, Petitioner commissioned in the Navy and served on active duty until released and transferred to the Navy Reserve on 25 August 2006.

c. On 26 August 2006, Petitioner assigned to the Navy Reserve Individual Ready Reserve and thereafter transferred to a drilling status effective 21 February 2017.

d. Petitioner's Navy Enlisted/Officer Participation System Member's Anniversary Summary ending 18 July 2022 reflected 50 inactive points for anniversary year ending 18 July 2008; 51

inactive points for anniversary year ending 18 July 2009; 50 inactive points for anniversary year ending 18 July 2010; 87 points for anniversary year ending 18 July 2017; and 20 qualifying years of service.

e. On 28 August 2023, Navy Personnel Command (PERS-912) generated Statement of Service for Navy Reserve Retirement reflecting adjustment to Petitioner's anniversary year from 19 July to 18 April; anniversary years ending 17 April 2008, 17 April 2009, 17 April 2010, and 17 April 2017 all changed to unsatisfactory years of service and qualifying years of service changed from 20 years to 17 years.

f. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

g. On 8 May 2024, Navy Personnel Command (PERS-912) generated Statement of Service for Navy Reserve Retirement reflecting adjustment to Petitioner's anniversary year from 18 April to 9 April; anniversary years ending 8 April 2008, 8 April 2009, 8 April 2010, and 8 April 2017 remained unsatisfactory years of service and qualifying years of service updated to 18 years.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. In accordance with reference (b),<sup>1</sup> the Board concluded Petitioner's anniversary year was erroneously established as 19 July and 18 April. When the Service corrected Petitioner's anniversary date to 8 April, her points were redistributed, resulting in not having the minimum 50 points for anniversary years ending 8 April 2008, 8 April 2009, 8 April 2010, and 8 April 2017. Therefore, the Board determined that under this circumstance, relief is warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's Statement of Service for Navy Reserve Retirement is amended to reflect anniversary years ending 8 April 2008, 8 April 2009, 8 April 2010, and 8 April 2017 have 50 inactive points per year and a satisfactory year of qualifying service per year.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.

<sup>1</sup> The anniversary year is calculated from an anniversary date. The date to determine the anniversary year is established by the date the Service member entered into active service or active status in a Reserve Component.
