1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 11 April 2022 for 3 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████ reviewed Petitioner's allegations of error and injustice on 9 April 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 25 September 2010, Petitioner's dependent child was born. On 21 February 2012, Petitioner got married.

b. On 18 June 2014, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 17 June 2018 and Soft EAOS (SEAOS) of 17 June 2020; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding

upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1511R)30. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.”

c. In March 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N24O.

d. On 10 March 2017, Petitioner reenlisted for 6 years with an EAOS of 9 March 2023 and received a Zone A SRB.

e. On 28 March 2017, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 13 April 2017 for duty.

f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

g. On 18 June 2020, Petitioner entered Zone B.

h. In accordance with reference (c), FY20 SRB Award Plan (N13SRB 004/FY20), a Zone “B” SRB with an award level of 6.5 (\$100,000 award ceiling) for the EMN(SW)/N24O/S rate/NEC was listed.

i. On 7 October 2020, Petitioner was issued official change duty orders (BUPERS order: 2810) with required obligated service to April 2024, while stationed in [REDACTED] with an effective date of departure of March 2021. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 30 April 2021 with a Projected Rotation Date of April 2024. Obligated service to April 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

j. On 1 February 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 13-month agreement to extend enlistment with an SEAOS of 9 April 2024.

k. On 25 March 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 23 April 2021 for duty.

l. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SW)/N24O/S rate/NEC was listed.

m. On 22 March 2024, Petitioner signed an agreement to extend enlistment for 12 months with a SEAOS of 9 April 2025 in order to obligate service in accordance with MILPERSMAN 1160-050 with NAVPERSCOM approval 12 March 2024.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 18 June 2020, Petitioner entered Zone B. On 7 October 2020, Petitioner was issued BUPERS order: 2810 with required obligated service to April 2024. At that time, a Zone B SRB was authorized in accordance with reference (c). On 1 February 2021, NSIPS/ESR shows a 13-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 11 April 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 13-month agreement to extend enlistment (NAVPERS 1070/621) operative on 10 March 2023 is null and void.

Petitioner's 12-month agreement to extend enlistment (NAVPERS 1070/621) executed on 22 March 2024 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 1 February 2021 agreeing to extend enlistment for 13 months for OBLISERV to April 2024.

Petitioner was discharged 10 April 2022 and reenlisted on 11 April 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SW)/N24O, rating/NEC. Remaining obligated service to 9 March 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant [REDACTED] Manager, [REDACTED] [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
