Subj: REVIEW OF NAVAL RECORD ICO

1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 21 April 2020 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Construction**, and **Construction**, and **Construction** reviewed Petitioner's allegations of error and injustice on 16 April 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 9 April 2014, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 8 April 2018 and Soft EAOS (SEAOS) of 8 April 2020; "Training in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

c. On 21 April 2017, Petitioner reenlisted for 6 years with an EAOS of 20 April 2023 and received a Zone A SRB.

d. In July 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N14S.

e. In accordance with reference (b), FY20 SRB Award Plan (N13SRB 002/FY20), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N14O/S rate/NEC was listed.

f. In January 2020, Petitioner was awarded NEC N33Z.

g. On 9 April 2020, Petitioner entered Zone B.

h. In accordance with reference (c), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

i. On 28 April 2020, Petitioner was issued official change duty orders (BUPERS order: 1190) with required obligated service to February 2024, while stationed in

with an effective date of departure of September 2020. Petitioner's intermediate (01) activity was a second second

j. On 5 July 2020, Petitioner signed an agreement to extend enlistment for 10 months with an SEAOS of 20 February 2024 in order to incur sufficient obligated service to execute BUPERS order 1190.

k. On 19 September 2020, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

m. In February 2021, Petitioner was awarded NEC 805A.

n. On 6 February 2021, Petitioner transferred from on 6 February 2021 for duty. and arrived to

o. In October 2023, Petitioner was awarded NEC N59X.

p. On 14 November 2023, Petitioner was issued official change duty orders (BUPERS order: 3183) while stationed in **Section 1** with an effective date of departure of November 2023. Petitioner's ultimate activity was **Section 1** for duty with an effective date of arrival of 28 November 2023 with a PRD of February 2024.

q. On 28 November 2023, Petitioner transferred from a strive of the stri

r. On 5 January 2024, Petitioner was issued official separation orders (BUPERS order: 0054) while stationed in **Sector 1** with an effective date of departure of January 2024. Petitioner's place elected for travel: **Sector 1** with an actual date of separation of 20 February 2024.

s. On 5 January 2024, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 2-month agreement to extend enlistment with an SEAOS of 20 April 2024.

t. On 17 January 2024, Petitioner was issued official modification to separation orders (BUPERS order: 0054) while stationed in **Sector 1999** with an effective date of departure of January 2024. Petitioner's place elected for travel: **Sector 1999** with an actual date of separation of 20 April 2024.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 9 April 2020 Petitioner entered Zone B. On 28 April 2020, Petitioner was issued BUPERS order: 1190 with required obligated service to February 2024. At that time, a Zone B SRB was authorized in accordance with reference (b). On 5 July 2020, Petitioner signed an agreement to extend enlistment for 10 months to meet the OBLISERV. The Board determined that Petitioner could have reenlisted vice extend enlistment. On 21 April 2020, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 10-month agreement to extend enlistment (NAVPERS 1070/621) executive on 5 July 2020 is null and void.

Petitioner's 2-month agreement to extend enlistment (NAVPERS 1070/621) operative on 21 February 2024 is null and void.

Petitioner was discharged 20 April 2020 and reenlisted on 21 April 2020 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.0" (\$100,000 award ceiling) for the EMN(SS)/N14S rating/NEC. Remaining obligated service to 20 April 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA) at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, <u>concerning SRB payment</u>.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
