1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's separation move was funded.

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 29 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 15 November 2023, U-Haul (Equipment Contract) issued Petitioner an equipment contract receipt for estimated rental charges of \$398.83.

b. On 2 February 2024, Petitioner was issued official separation orders (BUPERS order: ██████████) while stationed in ██████████ with an effective date of departure of May 2024. Furthermore, present CO directed to detach member in time to permit completion separation processing not later than 31 May 2024 IAW MILPERSMAN 1050-300 series.

c. On 5 February 2024, Petitioner signed an Application for Personally Procured Move and Counseling Checklist (DD Form 2278) listing a move from ██████████, ██████████ to ██████████, ██████████ with a maximum authorized weight of 14,500 lbs. and Estimated Government Constructive Cost of \$15,267.22. It was certified by a counselor on 5 February 2024.

d. Petitioner resigned with an honorable character of service and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 31 March 2017 to 1 May 2024 upon completion of required active service.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded per reference (b) Household Goods allowances are based on the when orders are effective and certain criteria must be met in order to execute Household Goods transportation before an order is issued. Petitioner was preparing for separation, therefore he had reason to believe that official separation orders would be forthcoming.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official separation orders (BUPERS order: [REDACTED]) were issued on "14 November 2023" vice "2 February 2024."

A copy of this report of proceedings will be filed in Petitioner's naval record.
