- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 25 January 2023 for 5 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB), and was eligible to transfer his education benefits.
- 2. The Board, consisting of previous previous previous previous previous Petitioner's allegations of error and injustice on 27 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 11 January 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 10 January 2021 and Soft EAOS (SEAOS) of 10 January 2023; "[t]raining in the Nuclear Field. MILPERSMAN 1530-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to rate and grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, 1 understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete nuclear power or advanced training."

Subj: REVIEW OF NAVAL RECORD ICO , USN,
b. In May 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N16O.
c. On 16 May 2019, Petitioner transferred from, and arrived to on 6 June 2019 for duty.
d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
e. On 4 July 2020, Petitioner got married.
f. On 25 March 2022, Petitioner reenlisted for 4 years with an EAOS of 24 March 2026 and eceived a Zone A SRB.
g. In June 2022 Petitioner was awarded NEC N16S.
h. In accordance with reference (c), FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N16O/S, ate/NEC was listed.
i. In December 2022 Petitioner was awarded NEC N33Z.
j. On 9 January 2023, Petitioner was issued official change duty orders (BUPERS order: 0093) with required obligated service to February 2027, while stationed in with an effective date of departure of September 2023. Petitioner's ultimate activity was for duty with an effective date of arrival of 26 October 2023 with a Projected Rotation Date of February 2027. Obligated service to February 2027, is equired for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible ailors.
k. On 11 January 2023, Petitioner entered Zone B.
1. On 30 July 2023, Petitioner signed an agreement to extend enlistment for 11 months with an SEAOS of 24 February 2027 in order to incur sufficient obligated service to execute BUPER order 0093.
m. On 26 September 2023, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.
n. On 26 September 2023, Petitioner transferred from on 26 October 2023 for duty.

o. On 22 August 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 9 January 2023, Petitioner was issued BUPERS order: 0093 with obligated service to February 2027. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 11 January 2023, Petitioner entered Zone B. On 30 July 2023, Petitioner signed an agreement to extend enlistment for 11 months to meet the OBLISERV. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b). On 25 January 2023, Petitioner would have been eligible to reenlist for 5 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 11-month agreement to extend enlistment (NAVPERS 1070/621) executed on 30 July 2023 is null and void.

Petitioner was discharged 24 January 2023 and reenlisted on 25 January 2023 for a term of 5 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N16S, rating/NEC. Remaining obligated service to 24 March 2026 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 25 January 2023 reenlistment. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). LT at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, LT concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
