1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 8 April 2022 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constant 1**, **Constant 1**, and **Constant 1**, and **Constant 1** reviewed Petitioner's allegations of error and injustice on 27 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 17 February 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 16 February 2020 and Soft EAOS (SEAOS) of 16 February 2022; "[t]raining in the Advanced Electronics Field (AEF)/Advanced Technical Field (ATF) program and advancement to paygrade E-4 per MILPERSMAN articles 1160-40 and 1510-030. I understand that this extension becomes binding upon execution and thereafter may not be cancelled except as set forth in MILPERSMAN article 1160-040. In particular, I understand that when I accept advancement to E-4, 12 months of this agreement may not be cancelled whether or not I complete advanced training."

b. In March 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N13O.

c. On 22 March 2018, Petitioner transferred from on 6 April 2018 for duty.

d. On 8 June 2018, Petitioner reenlisted for 6 years with an EAOS of 7 June 2024 and received a Zone A SRB.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In May 2020, Petitioner was awarded NEC N73Z. In March 2021, Petitioner was awarded NEC N13S.

g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

h. On 29 September 2021, Petitioner was issued official change duty orders (BUPERS order:) with required obligated service to May 2025, while stationed in

with an effective date of departure of April 2022. Petitioner's ultimate activity was for duty with an effective date of arrival of 13 May 2022 with a Projected Rotation Date of May 2025. Obligated service to May 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MIL PERSMAN 1206 106 nerg 4. Use of NAVIPERS 1070/612 only outhorized for SRB clicible

MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

i. On 3 December 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows an 11-month agreement to extend enlistment with an SEAOS of 7 May 2025.

j. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 001/FY22), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

k. On 17 February 2022, Petitioner entered Zone B.

1. On 14 April 2022, Petitioner transferred from **Constant and and arrived to** on 13 May 2022 for duty.

m. On 18 April 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

Subj: REVIEW OF NAVAL RECORD ICO XXX-XX-

The Board concluded that on 29 September 2021, Petitioner was issued BUPERS order: with required obligated service to May 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 3 December 2021, NSIPS/ESR shows an 11-month agreement to extend enlistment to meet the OBLISERV. On 17 February 2022, Petitioner entered Zone B. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b). On 8 April 2022, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 11-month agreement to extend enlistment (NAVPERS 1070/621) operative on 8 June 2024 is null and void.

Petitioner was discharged 7 April 2022 and reenlisted on 8 April 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13S, rating/NEC. Remaining obligated service to 7 June 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). **The second seco**
