1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 14 October 2023 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Construction**, **Construction**, and **Construction**, and **Construction** reviewed Petitioner's allegations of error and injustice on 20 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 13 October 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 12 October 2020 and Soft EAOS (SEAOS) of 12 October 2022; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306- 502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040 and 1510-030. In particular, I understand that when I accept advancement to

E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. In August 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N15O.

c. On 15 October 2018, Petitioner reenlisted for 6 years with an EAOS of 14 October 2024 and received a Zone A SRB.

d. On 6 December 2018, Petitioner transferred from and arrived to on 10 December 2018 for duty.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In accordance with reference (c), FY22 SRB Award Plan (N13 SRB 004/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S, rate/NEC was listed.

g. On 15 August 2022, Petitioner was issued official change duty orders (BUPERS order: 2272) with required obligated service to December 2025, while stationed in **Service**, **Se**

h. On 12 October 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 14-month agreement to extend enlistment with an SEAOS of 14 December 2025.

i. On 13 October 2022, Petitioner entered Zone B.

j. In November 2022 Petitioner was awarded NEC N15S.

k. On 10 November 2022, Petitioner transferred from **and arrived to** on 14 December 2022 for duty.

l. On 14 December 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

m. In June 2023, Petitioner was awarded NEC N77Z.

n. In accordance with reference (d), FY24 SRB Award Plan (N13 SRB 001/FY24), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S, rate/NEC was listed.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 15 August 2022, Petitioner was issued BUPERS order: 2272 with obligated service to December 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 12 October 2022, NSIPS/ESR shows a 14-month agreement to extend enlistment to meet the OBLISERV. On 13 October 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 14 October 2023, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 14-month agreement to extend enlistment (NAVPERS 1070/621) operative on 15 October 2024 is null and void.

Petitioner executed an administrative Remarks (NAVPERS 1070/613) on 12 October 2022 agreeing to extend enlistment for 14 months for OBLISERV to December 2025.

Petitioner was discharged 13 October 2023 and reenlisted on 14 October 2023 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N15S, rating/NEC. Remaining obligated service to 14 October 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
