- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 29 May 2023 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).
- 2. The Board, consisting of \_\_\_\_\_\_, \_\_\_\_\_, and \_\_\_\_\_\_ reviewed Petitioner's allegations of error and injustice on 17 September 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 11 May 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 10 May 2020 and Soft EAOS (SEAOS) of 10 May 2022; "[t]raining in the Nuclear Field. MILPER5MAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be canceled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months

b.	In June 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N23O.
c.	On 3 May 2018, Petitioner transferred from on 3 June 2018 for duty.

- 1. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 002/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the ETN(SW)/N23O/S, rate/NEC was listed.
  - m. In May 2024, Petitioner was awarded NEC N23S.

## **CONCLUSION**

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 29 September 2021, Petitioner was issued BUPERS order: with required obligated service to June 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 25 January 2022, NSIPS/ESR shows a 3-month agreement to extend enlistment to meet the OBLISERV. On 11 May 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 29 May 2023, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

## RECOMMENDATION


That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-month agreement to extend enlistment (NAVPERS 1070/621) operative on 29 March 2025 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 25 January 2022 agreeing to extend enlistment for 3 months for OBLISERV to June 2025.

Petitioner was discharged 28 May 2023 and reenlisted on 29 May 2023 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the ETN(SW)/N23S, rating/NEC. Remaining obligated service to 28 March 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.



A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
