1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 25 November 2022 for 3 years, and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constant and Constant and Constant and Petitioner's** allegations of error and injustice on 17 September 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 24 November 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 23 November 2019 and Soft EAOS (SEAOS) of 23 November 2021; "[t]raining in the Nuclear Field Program, and advancement to E-4, per BUPERSINST 1306.78 and MILPERSMAN 1160-040,1160-080, and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be canceled, except as set forth in MILPERSMAN 1160-040. In particular. I understand that, when I accept advancement to E-4, 12 months of this agreement may not be canceled, whether or not I complete Nuclear Power or Advanced Training."

b. In November 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N14O.

c. On 29 February 2018, Petitioner transferred from **12** February 2018 for duty.

d. On 26 November 2018, Petitioner reenlisted for 6 years with an EAOS of 25 November 2024 and received a Zone A SRB.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N14O/S, rate/NEC was listed.

g. In October 2021, Petitioner was awarded NEC N14S.

h. On 25 October 2021, Petitioner was issued official change duty orders (BUPERS order: 2981) with required obligated service to April 2025, while stationed in **Service**, with an effective date of departure of March 2022. Petitioner's ultimate activity was **Service** to April 2022 with a Projected Rotation Date of April 2025. Obligated service to April 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

i. On 18 November 2021, Petitioner signed an agreement to extend enlistment for 5 months with an SEAOS of 25 April 2025 in order to incur sufficient obligated service to execute BUPERS order 2981.

j. In November 2021, Petitioner was awarded NEC N33Z.

k. On 24 November 2021, Petitioner entered Zone B.

l. On 1 March 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

m. On 1 March 2022, Petitioner transferred from **March 2022**, and arrived to **March 2022** for duty.

n. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SS)/N14O/S, rate/NEC was listed.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 25 October 2021, Petitioner was issued BUPERS order: 2981 with required obligated service to April 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 18 November 2021, Petitioner signed an agreement to extend enlistment for 5 months to meet the OBLISERV. On 24 November 2021, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 25 November 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 5-month agreement to extend enlistment (NAVPERS 1070/621) executed on 18 November 2021 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 18 November 2021 agreeing to extend enlistment for 5 months for OBLISERV to April 2025

Petitioner was discharged 24 November 2022 and reenlisted on 25 November 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SS)/N14S, rating/NEC. Remaining obligated service to 25 November 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will<u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). LT**MEN** at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive.
