1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 11 December 2021 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 24 September 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 10 December 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 9 December 2019 and Soft EAOS of 9 December 2021. Furthermore, Petitioner enlisted in the Nuclear Field (NF 6YO) Program.

b. In January 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N150 and transferred from ██████████ on 15 May 2018 and arrived to ██████████ on 15 June 2018 for duty.

c. On 5 April 2019, Petitioner reenlisted for 6 years with an EAOS of 4 April 2025 and received a Zone A SRB.

d. On 31 July 2021, Petitioner got married.

e. On 25 October 2021, Petitioner was issued official change duty orders (BUPERS order: 2981) with required obligated service to June 2025, while stationed in [REDACTED] with an effective date of departure of February 2022. Petitioner's intermediate (01) activity was [REDACTED] for temporary duty under instruction with an effective date of arrival of 7 March 2022. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 25 June 2022 with a projected rotation date of June 2025. Obligated service to June 2025 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

f. On 10 December 2021, Petitioner entered Zone B.

g. In 1 February 2022, Petitioner was awarded NEC N15S.

h. On 8 February 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 8 March 2022 for temporary duty and his Master Military Pay Account shows that Petitioner's Submarine Pay stopped on 8 February 2022.

i. On 25 June 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 25 June 2022 for duty.

j. On 21 July 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 2-month agreement to extend enlistment with an Soft EAOS of 4 June 2025.

k. In October 2022, Petitioner was awarded NEC 805A.

l. On 7 December 2022, Petitioner's dependent child was born.

m. On 19 September 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 25 October 2021, Petitioner was issued orders with an obligated service to June 2025. At that time, a Zone B SRB was authorized in

accordance with reference (c)¹, however Petitioner was still in Zone A. On 10 December 2021, Petitioner entered Zone B. On 21 July 2022, NSIPS/ESR shows a 2-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b).² On 11 December 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents if he so chooses.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 2-month agreement to extend enlistment (NAVPERS 1070/621) operative on 5 April 2025 is null and void.

Petitioner was discharged 10 December 2021 and reenlisted on 11 December 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N15O, rating/NEC. Remaining obligated service to 4 April 2025 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 11 December 2021 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). LT [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, LT [REDACTED], [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and

² Announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
