1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 30 November 2022 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 30 July 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 6 August 2014, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 5 August 2018 and Soft EAOS (SEAOS) of 5 August 2020; "[t]raining in the Nuclear Field Program. MILPER3MAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 24 March 2017, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 26 April 2017 for duty.

c. On 30 April 2020, Petitioner reenlisted for 4 years with an EAOS of 29 April 2024 and received a Zone A SRB.

d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. On 6 August 2020, Petitioner entered Zone B.

f. In September 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N16S.

g. On 5 January 2021, Petitioner was issued official change duty orders (BUPERS order: 0051), while stationed in [REDACTED], [REDACTED], [REDACTED] with an effective date of departure of June 2021. Petitioner's intermediate (01) activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty under instruction with an effective date of arrival of 5 June 2021. Petitioner's ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 6 November 2021 with a Projected Rotation Date of November 2024.

h. On 11 March 2021, Petitioner was issued official modification to change duty orders (BUPERS order: 0051), while stationed in [REDACTED], [REDACTED], [REDACTED] with an effective date of departure of May 2021. Petitioner's intermediate (01) activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty with an effective date of arrival of 22 May 2021. Petitioner's intermediate (02) activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty under instruction with an effective date of arrival of 7 June 2021. Petitioner's ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 6 November 2021 with a Projected Rotation Date of November 2024.

i. On 20 April 2021, Petitioner was issued official modification to change duty orders (BUPERS order: 0051), while stationed in [REDACTED], [REDACTED], [REDACTED] with an effective date of departure of May 2021. Petitioner's intermediate (01) activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty with an effective date of arrival of 22 May 2021. Petitioner's intermediate (02) activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty under instruction with an effective date of arrival of 7 June 2021. Petitioner's ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 6 November 2021 with a Projected Rotation Date of November 2024.

j. On 20 May 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 21 May 2021 for temporary duty.

k. On 5 October 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

l. On 5 October 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 15 November 2021 for duty.

m. In December 2021, Petitioner was awarded NEC N76Z.

n. In accordance with reference (c), FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N16O/S, rate/NEC was listed.

o. On 25 April 2023, Petitioner signed an agreement to extend enlistment for 7 months with an SEAOS of 29 November 2024 in order to match EAOS with PRD of 24 November 2030.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 6 August 2020, Petitioner entered Zone B. On 5 January 2021, Petitioner was issued BUPERS order: 0051 with no obligated service directed; however, the PRD is November 2024 and Petitioner's EAOS was 29 April 2024. On 25 April 2023, Petitioner signed a 7-month agreement to extend enlistment to match EAOS to PRD. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b). On 30 November 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 7-month agreement to extend enlistment (NAVPERS 1070/621) executed on 25 April 2023 is null and void.

Petitioner was discharged 29 November 2022 and reenlisted on 30 November 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N16S, rating/NEC. Remaining obligated service to 29 April 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). LT [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay

the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, LT [REDACTED], [REDACTED], concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
