1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 11 December 2021 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 23 July 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 8 December 2014, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 7 December 2018 and Soft EAOS (SEAOS) of 7 December 2020; "[t]raining in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

- b. On 1 March 2017, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 2 March 2017 for duty.
- c. On 29 June 2017, Petitioner reenlisted for 6 years with an EAOS of 28 June 2023 and received a Zone A SRB.
- d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- e. In August 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N13S.
- f. On 8 December 2020, Petitioner entered Zone B.
- g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 002/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.
- h. On 17 February 2021, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with required obligated service to October 2024, while stationed in [REDACTED], [REDACTED], [REDACTED], with an effective date of departure of August 2021. Petitioner's intermediate (01) activity was [REDACTED], [REDACTED], [REDACTED] for temporary duty under instruction with an effective date of arrival of 5 September 2021. Petitioner's ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 11 October 2021 with a Projected Rotation Date of October 2024. Obligated service to October 2024, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- i. On 6 July 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 16-month agreement to extend enlistment with an SEAOS of 28 October 2024.
- j. On 6 August 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.
- k. On 6 August 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 6 September 2021 for temporary duty.
- l. In accordance with reference (d), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

m. On 7 October 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 8 October 2021 for duty.

n. In October 2021, Petitioner was awarded NEC N73Z. In June 2022, Petitioner was awarded NEC 805A. In October 2022, Petitioner was awarded NEC 8MTS.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 8 December 2020, Petitioner entered Zone B. On 17 February 2021, Petitioner was issued BUPERS order: [REDACTED] with required obligated service to October 2024. At that time, a Zone B SRB was authorized in accordance with reference (c). On 6 July 2021, NSIPS/ESR shows a 16-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 11 December 2021, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 16-month agreement to extend enlistment (NAVPERS 1070/621) operative on 29 June 2023 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 6 July 2021 agreeing to extend enlistment for 16 months for OBLISERV to October 2024.

Petitioner was discharged 10 December 2021 and reenlisted on 11 December 2021 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13S, rating/NEC. Remaining obligated service to 28 June 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the [REDACTED], [REDACTED], [REDACTED] [REDACTED], [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
