1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 12 April 2022 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 22 October 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 11 April 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 10 April 2020 and Soft EAOS of 10 April 2022; "[t]raining in the six year obligor (6YO) program for Nuclear Field/NF rating. I understand that this extension becomes binding upon execution, and may not be cancelled, except as set forth in MILPERSMAN 1160-0 40. Refer to NAVCRUIT 1133/52 Annex B to DD Form 4 dated 15 August 2005 Specific bonus guarantee."

b. In April 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N130.

c. On 11 May 2018, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 14 May 2018 for duty.

d. On 9 April 2020, Petitioner reenlisted for 5 years with an EAOS of 8 April 2025 and received a Zone A SRB.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In August 2021, Petitioner was awarded NEC N13S.

g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

h. On 18 November 2021, Petitioner was issued official change duty orders (BUPERS order: 3221) with required obligated service to May 2025, while stationed in [REDACTED] with an effective date of departure of April 2022. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 20 May 2022 with a projected rotation date of May 2025. Obligated service to May 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

i. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 001/FY22), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

j. On 15 March 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 1-month agreement to extend enlistment with a Soft EAOS of 8 May 2025.

k. In April 2022, Petitioner was awarded NEC N33Z.

l. On 11 April 2022, Petitioner entered Zone B.

m. On 14 April 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

n. On 14 April 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 20 May 2022 for duty.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 18 November 2021, Petitioner was issued orders 3221 with required obligated service to May 2025. At that time, a Zone B SRB was authorized in accordance with

reference (c), however Petitioner was still in Zone A. On 15 March 2022, NSIPS/ESR shows a 1-month agreement to extend enlistment to meet the obligated service. On 11 April 2022, Petitioner entered Zone B. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) and would have been eligible to reenlist for 4 years and receive a Zone B SRB on 12 April 2022.

#### RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 1-month agreement to extend enlistment (NAVPERS 1070/621) operative on 9 April 2025 is null and void.

Petitioner was discharged 11 April 2022 and reenlisted on 12 April 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13S, rating/NEC. Remaining obligated service to 8 April 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
