1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 15 November 2023 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 22 October 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 9 November 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 8 November 2020 and Soft EAOS of 8 November 2022; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12

months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.”

- b. On 12 October 2018, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 29 October 2018 for duty.
- c. In October 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N26O.
- d. On 17 January 2020, Petitioner reenlisted for 6 years with an EAOS of 16 January 2026 and received a Zone A SRB.
- e. On 24 January 2020, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 21 February 2020 for duty.
- f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- g. In accordance with reference (c), FY22 SRB Award Plan (N13SRB 002/FY22), a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SW)/N26O/S, rate/NEC was listed.
- h. On 27 June 2022, Petitioner was issued official change duty orders (BUPERS order: 1782), with required obligated service to April 2026, while stationed in [REDACTED] with an effective date of departure of November 2022. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 14 December 2022 with a projected rotation date of April 2026. Obligated service to April 2026, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- i. On 11 July 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 3-month agreement to extend enlistment with a Soft EAOS of 16 April 2026.
- j. On 9 November 2022, Petitioner entered Zone B.
- k. On 14 November 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 14 December 2022 for duty.
- l. In accordance with reference (d), FY24 SRB Award Plan (N13 SRB 001/FY24), a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SW)/N26O/S, rate/NEC was listed.

m. In November 2023, Petitioner was awarded NEC 805A. In May 2024, Petitioner was awarded NEC N26S. In August 2024, Petitioner was awarded NEC N89X.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 27 June 2022, Petitioner was issued orders 1782 with required obligated service to April 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 11 July 2022, NSIPS/ESR shows a 3-month agreement to extend enlistment to meet the obligated service. On 9 November 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment and would have been eligible to reenlist for 3 years and receive a Zone B SRB on 15 November 2023.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-month agreement to extend enlistment (NAVPERS 1070/621) operative on 17 January 2026 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 11 July 2022 agreeing to extend enlistment for 3 months for obligated service to April 2026.

Petitioner was discharged 14 November 2023 and reenlisted on 15 November 2023 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SW)/N26O, rating/NEC. Remaining obligated service to 16 January 2026 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] [REDACTED]. concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
