1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 12 January 2022 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 22 October 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 11 January 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 10 January 2020 and Soft EAOS of 10 January 2022; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. In February 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N140.

c. On 20 April 2018, Petitioner got married.

d. On 15 May 2018, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 16 May 2018 for duty.

e. On 27 December 2018, Petitioner reenlisted for 6 years with an EAOS of 26 December 2024 and received a Zone A SRB.

f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

g. In June 2021 Petitioner was awarded NEC N14S.

h. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N140/S, rate/NEC was listed.

i. On 19 October 2021, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with required obligated service to May 2025, while stationed in [REDACTED] with an effective date of departure of January 2022. Petitioner's intermediate (01) activity was [REDACTED] for temporary duty under instruction with an effective date of arrival of 7 February 2022. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 28 May 2022 with a projected rotation date of May 2025. Obligated service to May 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

j. On 11 January 2022, Petitioner entered Zone B.

k. On 17 January 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

l. On 17 January 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 7 February 2022 for temporary duty.

m. On 28 May 2022, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 28 May 2022 for duty.

n. In August 2022 Petitioner was awarded NEC 805A.

o. On 7 November 2022, Petitioner signed an agreement to extend enlistment for 5 months with a Soft EAOS of 26 May 2025 in order to incur sufficient obligated service to execute orders 2921.

p. In October 2023 Petitioner was awarded NEC N33Z.

q. On 18 October 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 19 October 2021, Petitioner was issued orders [REDACTED] with required obligated service to May 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 11 January 2022, Petitioner entered Zone B. On 7 November 2022, Petitioner signed an agreement to extend enlistment for 5 months to meet the obligated service. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) and would have been eligible to reenlist for 4 years and receive a Zone B SRB on 12 January 2022. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents if he so chooses.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 5-month agreement to extend enlistment (NAVPERS 1070/621) operative on 27 December 2024 is null and void.

Petitioner was discharged 11 January 2022 and reenlisted on 12 January 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.0" (\$100,000 award ceiling) for the EMN(SS)/N14S, rating/NEC. Remaining obligated service to 26 December 2024 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 12 January 2022 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's

incentive. Contact the [REDACTED], N133D, [REDACTED]
[REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
